

## **Hancock County Council Minutes July 12, 2023**

The County Council of Hancock County, Indiana met in the County Commissioner & Council Meeting Room in the Courthouse Annex located at 111 American Legion Place Greenfield, Indiana 46140 on the 12th day of July 2023 at the hour of 8:02 AM in accordance with the rules of the Council.
